On October 17, 2022, the LSBEP will begin accepting nominations from qualified licensees to participate in an election to fill the board member vacancy occurring **July 1, 2023**. BOARD REVIEW OF NOMINATIONS: The Board will open the Nominations submitted during their regularly scheduled on November 18, 2022

ELECTION PERIOD: The election period will begin following the opening of the nomination forms. Notices will be sent via email, through an online voting software management company. The election period will remain open for 30 days.

BOARD MEMBER ELIGIBILITY REQUIREMENTS UNDER La. R.S. 37:2353.A:

- (1) Citizen of the United States and resident of the state of Louisiana;
- (2) Has rendered service, teaching, training, or research in psychology for at least five years;
- (3) Has held a doctoral degree in psychology from a school or college as defined in this Chapter for a period of five years;
- (4) Has been licensed by the Louisiana State Board of Examiners of Psychologists for a minimum of five years;
- (5) Is not ineligible pursuant to La. R.S. 37:2353.A.(4) which states that "*no person shall be eligible to serve as a board member if he is employed by the board, has a contract with the board for services, or within the preceding twelve months of his nomination was employed by the board or had a contract with the board for services.*";
- (6) Current Board Members are not eligible to succeed themselves.

OTHER CONSIDERATIONS:

- (1) Board members are appointed by the governor from a list reporting the results of the election, which is provided to the governor by the Louisiana Psychological Association.
- (2) Board members shall serve without compensation but shall receive seventy-five dollars per diem allowance plus the mileage rate provided state employees to cover expenses incurred while engaged in the discharge of their duties.
- (3) Membership on the board of a public employee or official shall not constitute dual office holding within the meaning of R.S. 42:61 et seq.
- (4) Each appointment by the governor shall be submitted to the Senate for confirmation.
