Jaime Monic, LSBEP Executive Director was in attendance to facilitate the meeting, provide information and note-taking.

The ALCC reviewed and discussed the Minutes from Friday, June 12, 2020. Dr. Erin Reuther moved to approve the minutes with corrections as discussed. The motion being put to a vote of the ALCC members present, passed unanimously.

The ALCC continued discussing language for the definition of Assistant to Psychologist. Dr. VanGeffen and Dr. Reuther had questions regarding the intent of the changes related to registration of an Assistant to Psychologist. Participants from LSBEP revisited some of the issues and concerns the board has related to public protection that were presented in the first meeting. Dr. Boggs elaborated more on the issues. Questions were also posed related to the application of the proposed changes, and LPA participants raised concerns about the amount of contact that LSBEP would have with the assistant, wanting the relationship to remain between the LSBEP and the Licensee. Ms. Monic agreed to invite Attorney Newton to the next meeting to address questions and concerns related to the amount of oversight necessary to enable the board to protect the public.

Next meeting dates were discussed and the group confirmed their July 10 (2pm-4pm) meeting date.

The meeting adjourned at 4:00pm.
