Committee Members Present: George Hebert, , Katherine Chenier, and ExOfficio Member Jaime Monic. Stacey Johnson was absent.

Dr. Hebert moved to approve the agenda, Dr. Chenier seconded the motion. The motion was unanimously approved.

Dr. Hebert moved to approve the committee meeting minutes of May 19, 2020 and June 16, 2020 as amended. The motion was unanimously approved.

Ms. Stacey Johnson joined the meeting at approximately 2:00pm.

**Discussion Items:**

1. The Committee reviewed the LSSP reference form and discussed revisions to remove reference to NASP Accreditation. Ms. Johnson agreed to continue to review the form and make suggestions for revisions specifically related to intervention techniques, specifying special populations and omitting specific services.
2. The Committee continued the discussion related to NASP Accreditation Standards for Specialists Degrees vs. APA Proposed Accreditation Standards for Master's Level School Psychology Programs.

Dr. Hebert moved to enter Executive Session to conduct file reviews on applicants for licensure. The motion passed unanimously. Dr. Hebert moved to exit Executive Session to enter the following:

Dr. Hebert reviewed the Application for Licensed Specialist in School Psychology of **Jolie Guidry**. Finding that the requirements for licensure have been met, Dr. Hebert moved that the Committee confirm the Candidacy status of Ms. Guidry and recommend her to the Board for licensure as a Specialist in School Psychology pending receipt of passing Jurisprudence Examination. The motion passed unanimously.

Dr. Chenier moved to adjourn at 3:22 p.m., Dr. Hebert seconded the motion. The motion passed unanimously. The meeting adjourned at 3:22 p.m.
